The language in the proposed amendment is vague and subjective and could have a devastating effect on Community Plans and Specific Plans. "substantial conformance with the purpose, intent, and provisions of the General Plan..." "conforms with the intent of those regulations." How much is "substantial"? How do you define "intent"? Under these provisions, the Zoning Administrators will have broad interpretive powers and be making decisions previously made by City Council.

In the past, Commissioner Kezios and others have wisely questioned why the City of Los Angeles grants so many zoning variances. Under these Core Findings the number of variances will surely grow even larger.

The Federation urges you to refer the Core Findings Ordinance back to the Planning Department to revise the language so that it will protect the integrity of Community Plans and Specific Plans.
