PRESIDENT'S MESSAGE:

EDITOR RON KAYE TO ADDRESS FEDERATION

Ron Kaye is no stranger to speaking out. Now retired, he says, he will do just that at the November meeting on November 5 and comment on major issues of concern to us all.

His background is extensive. During his 21 years at the Daily News, Ron Kaye helped make the paper the Voice of the Valley, fighting for respect for an under-served community and a fair share of city resources.

He started in journalism as a police reporter in his hometown at the Cleveland Plain Dealer. Over the next two decades, he worked in nine news organizations from Alaska to Alabama, from New York City to Australia where his most significant contribution was leading a strike by 600 journalists against media mogul Rupert Murdoch for slanting stories during the constitutional crisis of 1975.

He came to Los Angeles in 1980 and took a job on the city desk at the Herald Examiner where he led coverage of big stories like the "Twilight Zone" tragedy and bright stories like "Bus Riders turn Crime Fighters. After the death of John Belushi, he produced a series called "Overdose: Hollywood, drugs and the LAPD."

LaBonge fights large METRO project for new NBC home

Protesting the size of a proposed commercial project in Universal City, Councilman Tom LaBonge on Thursday said he will use whatever powers he has on the City Council to significantly scale back the development. "This project will absolutely overwhelm this area and ruin a park space," LaBonge said at a news conference at the Red Line station on the project site at Lankershim and Camp de Cahuenga.

He was joined by more than a dozen neighborhood council and homeowner groups opposed to the development. "What they are talking about is just too big for the area and there is not enough mitigation required to deal with the traffic." The \$800 million project, in the planning stage for more than two years, calls for the construction of twin 24-story towers 390 and 362 feet tall, plus a five-story studio complex and a 34-story high-rise to be built over the next eight years.

The project will serve as the new home for NBC, which is leaving its Burbank headquarters. It is proposed for Metropolitan Transportation Authority land. LaBonge sent a letter to Mayor Antonio Villaraigosa, who chairs the MTA board, asking that the plan be significantly scaled back or moved to the Universal Studios lot, which has more than 400 acres of land available.

Among other things, LaBonge said he believes that the developer, Thomas Properties Group TPG, should be required to provide an access ramp from the 101 Freeway to the eastbound 134 Freeway, in addition to a southbound ramp directly from Universal Studios to the Hollywood Freeway.

Councils and Homeowner/Resident groups from Cahuenga Pass, Studio City and Toluca Lake have formed the **Committee United for Smart Growth, headed by Roy Disney**, which has negotiated with the MTA and the developer to try to scale back the project, without any success. "Every time we meet with them, they come back with an even bigger plan," said Richard Bogy of the Toluca Lake Chamber of Commerce and a member of the committee.

MTA officials said they will try to address LaBonge's issues. "We do understand his concern and we all want to make sure we are doing the right thing," said Roger Moliere, who is negotiating the MTA contract. "This is an important project, one we see as an opportunity to do transit-oriented development in an area where we have transit options." Moliere said the plans call for millions of dollars of mitigation, but the final contract is still being negotiated. Final action is expected in December.

"Thomas Properties spokesman Rob Stutzman said the project must be large to be economically viable."

(So who's responsibility is it to make a project viable? Isn't that the developer's problem? Proposing an oversized, incompatible and unmitigated project in order to be economically viable should not be born at the expense of the surrounding communities.) "I think once the councilman is made aware of that, he will understand what we are doing," Stutzman said. "Also, we think this is a moderate-sized project when it's compared to some of the others the MTA is looking at." LaBonge said he is looking at what powers the City Council has as far as zoning and land use that could slow down and scale back the development.

Villaraigosa, however, is standing by the project. "It will provide a shot in the arm to L.A.'s signature industry, generate thousands of jobs and promote the use of mass transit, said the mayor. "At a time when the economy is hemorrhaging jobs and traffic is grinding to a halt, we would hope that the councilman would understand that this is exactly the kind of smart, transit-friendly project we need."

CITY FOUND GUILTY OF BROWN ACT VIOLATIONS



A Los Angeles Superior Court judge has issued a decision agreeing with the LaMirada Avenue Neighborhood Association of Hollywood that the mere listing of a project environmental number on a meeting agenda violates California's Opening Meeting Law, known as the Brown Act. LaMirada challenged the validity of certain California Environmental Quality Act (CEQA) decisions made by the City Planning Commission regarding the Paseo Plaza mixed use project proposed for the old Sears Roebuck site on Santa Monica Boulevard.

LaMirada argued that the average person looking at a meeting agenda would have no idea what an environmental case number meant or that the Planning Commission was proposing to take actions to approve environmental documents. The Court condemned the City's practice of just listing a number like: "ENV-2007-9348-MND" as providing any hint that a committee or Council was intending to take proposed actions to adopt an environmental document.

Although LaMirada had already settled with the City and Developer over the Paseo Plaza project, the Court went forward on the remaining question in the case of whether the City had a "pattern and practice" of routinely violating the Brown Act and CEQA with no agenda description of proposed environmental action. Having found the practice to be a blatant violation of law, the Court will now consider issuing a permanent injunction requiring the City to put into place policies to end this decades long practice. LaMirada was represented by the Silverstein Law firm and the City will also likely pay substantial attorneys fees for forcing the community to litigate the case all the way to trial.

Support for Griffith Park/Historic Cultural Monument Nomination

October 21, 2008

Dear Mr. Barron and Cultural Heritage Commissioners:

The Federation of Hillside and Canyon Associations, representing thirty-six residents' organizations from Glassell Park to Pacific Palisades, strongly supports the nomination of the entire Griffith Park as a City of Los Angeles Historic-Cultural Monument.

Griffith Park is without a doubt one of the most historic of all the City parks. It was the Christmas gift of Griffith J. Griffith to the people of Los Angeles in 1896. Griffith understood the need for sunlight and fresh air and recognized public parks as "the safety valve of great cities."

Griffith Park is intrinsically linked to other prominent figures in Los Angeles history, Jose Vicente Feliz and Don Antonio Colonel. The park contains thirty-six identified historic resources including the Gabrielino Indian site in Fern Dell. Its largest historic resource is the urban wilderness area which fulfills Col. Griffith's vision of a place for the plain people to escape from the hustle and bustle of the big city. It is this vast urban wilderness in the midst of this sprawling metropolis that makes Griffith Park unique among the great parks in the United States.

While it may seem unusual to designate a park as an Historic-Cultural Monument, it is not without precedent. Indeed, eight City parks already enjoy the protection afforded by Historic-Cultural Monument status. Appropriate modifications can be made. City Hall, the Griffith Observatory and Barnsdall Art Park have all gone through extensive renovations.

City parks that are monuments continue to function successfully and thrive without any problems maintaining their infrastructure.

City Council now has the opportunity to preserve and protect our incredible Griffith Park for future generations to enjoy. What greater gift could the Council members give to their constituents. The Federation urges you to support Griffith Park's nomination as an Historic-Cultural Monument.

OCTOBER MINUTES

DRAFT MINUTES HILLSIDE FEDERATION

General Membership Meeting October 7, 2008

The meeting convened at 7:47 p.m. at Universal City Nissan with self introduction of members and guests. A quorum being absent, approval of minutes and action items were postponed.

PRESIDENT'S REMARKS:

CULTURAL HERITAGE COMMISSION:

A hearing regarding Griffith Park's Nomination for Historic-Cultural Monument status will be held on Thursday, October 30. Attendance was urged.

DENSIFICATION ORDINANCE LAWSUIT:

EAHCLA offer was rejected by City Attorney at a Mandatory Settlement Conference. Another hearing is now set for March.

NORTHEAST HILLSIDE ORDINANCE:

Planning Associates Gabriela Juarez and Nick Marincich presented details of this zone change, noting that it is not technically a zone change, but the addition of Q and D conditions. A 12 page ordinance with 61 pages of explanation was made available. The ordinance would take effect as the current Interim Control Ordinance expires on January 12, 2009. Community sentiment is mixed. October 14th PLUM hearing date was postponed to November 18th.

METRO STUDIO @ LANKERSHIM:

This is the second presentation by the development team of Thomas Properties, Vice President Ayalushum Hammond, Traffic Planner Pat Gibson and Architect Paul Danna. Comments on the E.I.R. are due November 24. The green aspects of the project were stressed as well as increased sensitivity to the cultural/historical significance of Campo de Cahuenga. Pat Gibson discussed exhaustive intersection analysis --- 164 intersections with many signal improvements and landscaping. Reduction of 20% employee traffic is a goal to be met by free transportation passes, ride shares, showers for

bicyclists and provision of flex cars. The creation of pedestrian/auto grade separation is being considered. The mammoth impact of the first phase and the additional residential phase was lamented by President Luchs as "having nothing to do with affordable housing. Cahuenga Blvd West can not accommodate more traffic without ruining the Cahuenga Pass community." Other local residents indicated, "Right now, even before the project is a reality, we can't get in or out of our local streets. We do not have safe access."

BRUSH CLEARANCE:

MRCA Chief Ranger Walt Young reported 100% brush clearance on their properties. 24 hour patrols are maintained on Red Flag days. MRCA is testing "force multipliers" --- technology devices to alert rangers and law enforcement to intrusions, vandalism or fire. "Spec" sheets on two of these devices were provided.

FILM PERMITS IN FIRE AREAS:

Benedict Canyon President Nickie Miner requested support for a strengthened Hillside Fire Zone ordinance. She stated that current film permits are being approved allowing outdoor smoking without requiring Fire Marshals to be present, thus creating hazards that put their community at great risk which must be stopped. A more detailed discussion of this problem was deferred to the November meeting.

MULHOLLAND CORRIDOR:

Director Barbara Dohrmann reported that contrary to previous commitments by Stephen S. Wise Temple and Bel Air Presbyterian Church, current building plans and facilities uses are inconsistent with those commitments, resulting in a negative impact on nearby residents.

Meeting adjourned at 10:15 p.m.

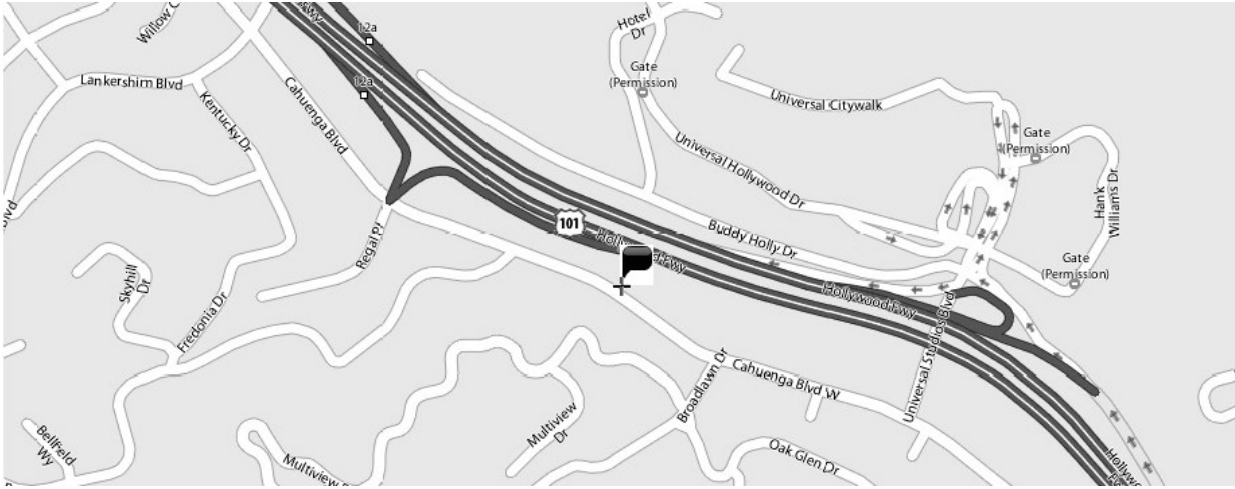
